Ordinance No. 23 of the Rector of Poznan University of Technology of 14 August 2024 (RO/VIII/23/2024)

on organizational changes

Acting pursuant to Article 23 of the Act of 20 July 2018 - Law on Higher Education and Science (Journal of Laws of 2023, item 742, as amended), it is ordered as follows:

§1

The organizational structure of the University, introduced by Ordinance No. 51 of the Rector of Poznan University of Technology of 28 September 2020 on the organizational structure of Poznan University of Technology, managerial duties and tasks of the Vice-Rectors, Chancellor and Bursar (RO/IX/51/2020), is amended as follows:

- 1. At the Faculty of Architecture, the Division of Urban Planning is transferred from the Institute of Architecture, Urban Planning and Heritage Protection (Z3) to the Institute of Architecture and Physical Planning (Z2).
- 2. At the Faculty of Architecture, in the Institute of Architecture, Urban Planning and Heritage Protection (IAu), the potential of the Division of Public Architecture and Housing (Z1) is used to create the Division of Housing (Z1) and the Division of Public Architecture (Z2), while the Division of History, Theory and Heritage Protection (Z2) is transformed into the Division of History and Heritage Protection (Z3).
- 3. At the Faculty of Architecture, the Institute of Architecture, Urban Planning and Heritage Protection (IAu) changes its name to the Institute of Architecture and Heritage Protection (IAu).
- 4. At the Faculty of Architecture, in the Institute of Architecture and Physical Planning, the potential of the Division of Architecture of Workplaces and Recreation (Z1) and of the Division of Technology in Architecture (Z2) is used to create the Division of Sustainable Design (Z1).
- 5. At the Faculty of Civil and Transport Engineering, in the Institute of Machines and Motor Vehicles, the Division of Food Machines and Food Transport (Z2) is transformed into the Division of Specialized Transport (Z3), and the Division of Motor Vehicles changes the symbol to Z2.
- 6. At the Faculty of Civil and Transport Engineering, in the Institute of Combustion Engines and Powertrains, the potential of the Division of Alternative Powertrains (Z2) and of the Division of Combustion Engines (Z3) is used to create the Division of Powertrains (Z2).
- 7. At the Faculty of Civil and Transport Engineering, the Institute of Combustion Engines and Powertrains (IS) changes its name to the Institute of Powertrains and Aviation (IS).
- 8. At the Faculty of Mechanical Engineering, the Division of Additive Manufacturing and Virtual Reality (Z4) is created in the Institute of Material Technology.
- 9. At the Faculty of Environmental Engineering and Energy, in the Institute of Thermal Energy, the Division of Aerospace Engineering (Z1) is transformed into the Division of Aerodynamics and Fluid-Flow Machinery (Z1).
- 10. The position of the third Deputy Bursar (RK3) is created.

11. The Project Settlement Section of the Accounting Office (RK1K) is transformed into the Project Settlement Office (RK3P) and is subordinated to the Deputy Bursar (RK3).

§2

The implementation of the Ordinance is entrusted, in accordance with their respective competences, to:

- 1) the Directors of the institutes which change their structure,
- 2) the Bursar,
- 3) relevant central administration units.

§3

The Ordinance enters into force on the day of signing with effect from 1 September 2024.
