## Statute of Poznan University of Technology

- 1. Poznan University of Technology is a state-owned institution of higher education having legal personality.
- 2. The registered office of Poznan University of Technology is: 5 M. Skłodowska-Curie Square, 60-965 Poznan.
- 3. Poznan University of Technology, hereinafter referred to as PUT, was formed by virtue of the resolution number 701 of the Council of Ministers, dated 3<sup>rd</sup> September 1955 regarding organizational changes in Higher Technical Education (Monitor Polski, number 83, item. 987). PUT continues the traditions of preceding Polish technical schools located in Poznan State University School of Machine Design formed in 1919 as transformed into State University School of Machine Design and Electrical Engineering in 1928 as well as School of Engineering formed in 1945 and Evening School of Engineering formed in 1950.
- 4. PUT continues its activity by virtue of the Act of 20th July 2018 The Law on Higher Education and Science (Journal of Laws 2023, item. 742 as later amended), hereinafter referred to as the Act, other regulations regarding university schools and the Statute.
- 5. The scope of activity of PUT is determined, respectively, by article 11 of the Act.
- 6. PUT is administered, in the scope determined by the Act, by the ministry responsible for higher education.
- 7. The Rector manages the university's activities and represents it outside. In particular, the Rector makes decisions regarding the university's property and administration, exceeding the scope of the ordinary university's management.
- 8. Vice-rector for Research supervises the overall activity related to the realization of scientific research. In this respect, the Vice-Rector is authorized to conclude agreements on behalf of the Poznan University of Technology.
- 9. Poznan University of Technology has the following statistical number, according to REGON a system of identification of entities: 000001608.
