

Resolution No. 56/2024-2028 of the Senate of Poznan University of Technology of 20 June 2025

on the amendment of Resolution No. 53/2024–2028 of the Senate of Poznan University of Technology of 30 April 2025 regarding the conditions and procedure for admission to studies in the academic year 2026/2027

Acting pursuant to Article 70 Section 1, in connection with Article 70 Section 5g and Article 28 Section 1 Point 10 of the Act of 20 July 2018 – Law on Higher Education and Science (Journal of Laws of 2024, item 1571, as amended), the Senate of Poznan University of Technology hereby **resolves** as follows:

§ 1

In Resolution No. 53/2024–2028 of the Senate of Poznan University of Technology dated 30 April 2025 concerning the conditions and procedure for admission to studies in the academic year 2026/2027, the following amendments are introduced:

- 1) in § 1 Section 3, after the words "recruitment for studies", the words "of Polish citizens" shall be added";
- 2) in § 1, after section 3, a new section 3a shall be added as follows:

"3a. Decisions regarding the admission of foreign nationals to studies shall be made by the Rector. The recruitment process shall be carried out by the International Student Recruitment Committee (ISRC), appointed by the Rector.";

- 3) in § 2 Section 5, after the words "according to the rules specified", the words "in § 3a, § 4a and" shall be added;
- 4) after § 3, a new § 3a shall be added as follows:

"§ 3a

- 1. A foreign national who holds a certificate of secondary school graduation or another document referred to in Article 69 Section 2 of the Law on Higher Education and Science may be admitted to first-cycle studies.
- 2. Upon submission to the ISRC of an equivalent secondary school leaving certificate, the Committee shall be responsible for converting the grades from the certificate to the scale used in the Polish system.
- 3. The University shall verify the foreign national's proficiency in the language of instruction of first-cycle studies at a level not lower than B2, based on a document specified in regulations issued pursuant to Article 70 Section 5f.
- 4. Foreign nationals holding a document referred to in Article 326a Section 1 shall be admitted to first-cycle studies under the rules laid out in § 3, excluding the provisions of § 3 Section 3.
- Foreign nationals who do not hold the document referred to in Article 326a Section 1 of the Law on Higher Education and Science shall be admitted to first-cycle studies under the rules set out in § 3:
 - 1) excluding the provisions of § 3 Section 3,

2) and shall sit an entrance examination conducted to assess knowledge in areas necessary for undertaking studies, as referred to in Article 70 Section 5b Point 3a of the Law on Higher Education and Science; a condition for proceeding to the next stage of the qualification process is passing the examination, i.e. obtaining at least 30%,

- 3) and shall also submit, during the recruitment process, a document issued abroad by a school or educational institution recognised by the state in which or under whose education system it operates, together with a written confirmation issued by the Director of the National Agency for Academic Exchange NAWA confirming the eligibility to apply for admission to studies, or— in cases referred to in Article 93a of the Act of 7 September 1991 on the Education System and Article 70 Section 5b Point 1 of the Law on Higher Education and Science a written confirmation from the Director of the National Agency for Academic Exchange NAWA or a decision of the education superintendent confirming secondary education and eligibility to apply for higher education.
- 6. The assessment of artistic aptitude referred to in § 3 Section 2 Point 2 for foreign nationals shall be based on a portfolio review. A positive result, defined as a minimum of 120 points, is required for further qualification.";
- 5) after § 4, a new § 4a shall be added as follows:

"§ 4a

- 1. A foreign national who holds a diploma of graduation from first-cycle or long-cycle master's studies may be admitted to second-cycle studies.
- 2. Foreign nationals who hold a document referred to in Article 326 Section 1 or Article 327 Section 1 of the *Law on Higher Education and Science* shall be admitted to second-cycle studies under the rules set out in § 4.
- 3. Foreign nationals who do not hold a document referred to in Article 326 Section 1 or Article 327 Section 1 of the Law on Higher Education and Science shall be admitted to second-cycle studies under the rules set out in § 4, and, during the recruitment process, shall submit a diploma of graduation issued abroad by a higher education institution recognised by the state in whose territory or higher education system it operates, together with a written statement concerning the diploma issued by the Director of the National Agency for Academic Exchange NAWA confirming the holder's eligibility to apply for admission to studies, as referred to in Article 70 Section 5d Point 1 of the Law on Higher Education and Science.
- 4. Upon submission to the ISRC of an equivalent diploma of graduation, together with the documents referred to in § 9 Section 1 Point 2c, the Committee shall be responsible for verifying the achievement of learning outcomes on the basis of a list of subjects the candidate studied at the previous level of education. Candidates who meet the requirements shall be referred to an entrance examination in the form of a qualification interview or a test conducted online or in person to assess their aptitude for undertaking the studies.
- 5. The University shall verify the foreign national's proficiency in the language of instruction of the secondcycle studies at a level of language competence not lower than B2, on the basis of a document specified in regulations issued pursuant to Article 70 Section 5f of the Law on Higher Education and Science."

This Resolution shall enter into force on the date of its adoption.
